


KCPP Animal Services Division Report for September 2024

Citations Issued / Enforcement

In September 2024, officers issued **ninety-eight (98)** criminal citations through the Thin Blue Line (TBL) system for review/issuance by the City Prosecutor. In addition, officers issued thirty-eight (38) verbal warnings for violations and two (2) official Notice to Correct Violation warning tickets to residents. Prior to the issuance of citations, verbal and/or written warnings for violations are presented by the officer, and citations are not submitted if compliance with animal ordinances are achieved within the given corrective action period. *A total of 660 criminal citations through Municipal Court have been issued so far in 2024.*

Community Presence

Animal Services Officers had 9 patrol vehicles in use daily in September. Officially marked patrol vehicles spent **931 hours** in the community and traveled **18,790 miles** throughout the city providing essential field services to our community.

Animal Services Division – Total Case Activities for September

Officers performed **2,102 total case activities** and were dispatched to **1,274 unique cases** in September -- composed of all calls from residents received through the 311 Call Center or direct calls to Animal Services dispatch team, online reports submitted via the website by residents, and the additional follow up activities required to resolve cases or ensure compliance.

Animal Services Dispatch – Call Center Metrics

During the hours of 7 AM – 10 PM every day, our Dispatch Specialists handle all incoming calls from residents through the City's 311 Call Center, direct calls to our Animal Services' Dispatch Team, and our after-hours phone queue. (Dispatchers also receive reports from residents via email through our website). Each reported animal-related concern is documented by location, assigned based on priority, and logged by council district as well as zip code.



Dispatch 311 Queue: Incoming calls from the KCMO 311 menu that are routed to KC Pet Project for animal control-related issues. **Dispatch Queue:** Calls received from residents who call us directly to report an animal control-related issue or concern. **Dispatch After Hours Queue:** Calls received between the hours of 7pm- 7am that are primarily answered by a designated "on-call" officer.

- ✓ Our Animal Services Dispatch team answered 2,587 live phone calls, completed 565 outbound calls, and resolved 127 voicemails.
- ✓ The Cruelty Tips Hotline received **7** calls in the month of September.
- Dispatchers spent 62 hours and 26 minutes on the phones last month and maintained an average wait time for calls to be answered at just 33 seconds in the direct Dispatch queue with a call abandonment rate of only 7%.

Total Cases by Sub-Type Responded to in September 2024

Calls related to stray animals continue to comprise nearly half of our monthly call volume from residents. Approximately **143** (25%) of the **576** stray/loose animal calls were related to public safety concerns, such as reports of aggressive dogs or animals in the roadway.

Animal Cruelty/Neglect/Abuse Cases Under Investigation

At the end of September, the Cruelty Investigations Team had 29 open animal cruelty cases under investigation.

- ✓ 23 reports of general neglect
- ✓ 4 reports of abandonment
- ✓ 2 reports of cruelty


Throughout September, the Cruelty Investigation Team investigated and closed **223** animal cruelty case activities for our community, including **43** reports of animal abandonment, **154** reports of neglect, **25** reports of cruelty and 1 report of dogfighting.



Case Results for September 2024

Fifty-four (54) loose/lost animals (48 dogs, 4 cats, and 2 horses) that could be returned in the field were reunited with their owners by officers, rather than impounding them at the shelter. This practice allows our officers to build trustbased relationships with our community, keeps pets safe at home, and allows for connection to resources if needed. Additionally, it preserves limited shelter resources for those animals truly in need of sheltering.



Total Number of Animal Services Cases by City Council District for September 2024




Compliance / Inspections / Permits

In September, Compliance Officer Oertwig issued three (3) Animal Display Permits, nine (9) Commercial Animal Establishment Permits, no Domestic Animal Advocation Permits, and no Special Exception for Fowl or Small Animal Permits issued pursuant to chapter 14-15 of the Kansas City municipal code of ordinances.

*The number of dogs impounded by Animal Services was up **14%** in September and is up **14%** from 2023. The number of cats impounded year-to-date is up more than **28%** over 2023 due to several large scale over-the-limit neglect cases.

Media Coverage/Public Education/Community Engagement

- On September 3rd, Chief Ryan Johnson, Manager LaDue, Officer Bryant, and Officer Hopkins attended the annual "Bark at the Park" event at Kauffman Stadium, handing out information, engraved pet ID tags, and dog treats.
- On September 7th, Animal Services Officers Bryant and Stapp represented the division at the annual "Bark in Sculpture Park" community event handing out 39 pet ID tags and lots of dog treats.
- On September 11th, the Animal Services Division collaborated with Port KC workers to round up seven stray goats from Berkley Riverfront Park (see Stories from the Field).
- On September 11th, Chief Johnson and Manager LaDue attended the annual Wildlife Hazard Management Plan review at the Kansas City Municipal Airport to provide input on plan revisions.
- On September 18th, 1st Assistant City Prosecutor Laura Dold visited the KCPP campus to train officers on courtroom effectiveness and case preparation.
- On September 19th, Chief Ryan Johnson participated in the monthly National Animal Control Association (NACA) Board of Director's meeting.



- On September 25th, Chief Ryan Johnson taught a course on "Building and Sustaining Partnerships" to animal control professionals across the U.S. as part of the NACA and Maddie's Fund instructor-led programs.
- On September 30th, Chief Ryan Johnson was a featured speaker at the Tennessee Animal Care and Control Conference in Gatlinburg, TN and gave a presentation entitled "Public Perception and Animal Handling."
- KC Pet Project had 26 news stories and 84 broadcast mentions in September, reaching an audience of 197,579,320 million people.



Directed Patrol Areas

Frequently, our Animal Services Division receives reports from residents of dogs habitually roaming a neighborhood or dogs that have become a public safety concern or nuisance problem for a specific neighborhood. However, sometimes

officers are unable to locate the dog(s) when they arrive. To resolve ongoing cases of this nature and to provide continued enforcement efforts for these issues, directed patrols have been established whereby officers schedule frequent drive-bys through these specific areas looking for the dogs. The following locations are currently identified as **Directed Patrol Areas** where officers are looking for dogs reported as habitually roaming, public nuisances, or aggressive dogs:

Public Safety Activities and Investigations

- In September, Animal Services Officers responded with KCMO city staff from Neighborhoods and Public Works to abate on-going issues of unleashed/loose dogs originating from a houseless encampment near 24th Street and Troost Avenue. Animal Services will continue to work toward obtaining compliance in this matter, even after the issuance of municipal court citations to the owner for various KCMO code violations.
- Throughout September, Animal Services Officers issued 13 municipal court citations in various cases where a dog was creating a public nuisance, including dogs having attacked other animals and/or causing injury to a person.
- Officers responded to 100 separate reports of loose dogs in various neighborhoods being reported as acting aggressively towards residents.
- In September, two (2) dogs were declared Potentially Dangerous and both declarations were upheld by the Administrative Hearing Judge.

- Animal Services is holding one (1) dog at the shelter pending owner compliance with the mandatory requirements outlined in Sec. 14-29 of the Municipal Code of Ordinances for dogs deemed Dangerous or Potentially Dangerous.
- Officers responded to twelve (12) cases of stray dogs reported on school grounds or at a daycare facility.
- As of September 30th, Animal Services Officers were actively investigating one
 (1) case of prohibited ownership of a "dangerous animal" in KCMO specifically the ownership of several Wolf-Dog Hybrids.

Stories from the Field - The Great Goat Round Up

In September, the Animal Services Division carried out a large-scale goat roundup operation in Berkley Riverfront Park. In early August, the division began receiving reports from the community about a number of loose goats wandering the riverfront area. Prior to these reports, the division had been aware of a herd of goats being used to clear brush in the area, but all those goats had been accounted for by the contractor and were removed after the project ended.

Throughout August, multiple attempts were made by Animal Services Officers to capture the remaining 10 goats, but due to the vast area and rocky terrain they roamed, the goats evaded capture.

Three goats were eventually rescued after becoming trapped in a small enclosure, but seven still remained at large. Ear tags on the goats proved unhelpful at finding the owner who had abandoned their herd of goats in this area.

On September 11th, Animal Services Officers teamed up with Port KC employees and local goat expert Margaret Chamas for a full-scale roundup, starting early in the morning. Officers utilized the natural terrain, corral fencing, and livestock panels to create barriers, pushing through dense brush along the steep and rocky southern banks of the Missouri River – herding the goats into a livestock trailer. Officers battled heat, hornet nests, sharp rocks, thick



vegetation, and uncooperative goats. After several hours, the last two wayward goats finally entered the trailer, and the gate was secured. All seven goats received on-site medical evaluations from our shelter's veterinary team, including immediate medical care for a goat with an injured hoof, and all seven goats were taken to the shelter to complete their mandatory five-day stray hold. Since no owner came forward, the goats were adopted out to new homes, and we hope their wandering days on the rocky riverbanks of Kansas City are over.
