THE SHELTER BEGAN THE YEAR WITH 471 ANIMALS. IN 2017 A TOTAL OF 9,854 ADDITIONAL ANIMALS WERE BROUGHT TO THE SHELTER BY ANIMAL CONTROL OR THE PUBLIC SO A TOTAL OF 10,325 ANIMALS WERE PROVIDED SHELTER SERVICES IN 2017. OF THIS TOTAL, 6,621 WERE ADOPTED, 1,375 WERE RETURNED TO THEIR OWNER, 853 WERE TRANSFERRED TO OTHER ANIMAL WELFARE ORGANIZATIONS. WE ENDED THE YEAR WITH 519 ANIMALS STILL IN OUR CARE. WE ACHIEVED AN OVERALL LIVE RELEASE RATE OF 95% FOR 2017.
