IN 2020 A TOTAL OF 10,082 ADDITIONAL ANIMALS WERE BROUGHT TO THE SHELTER BY ANIMAL CONTROL OR THE PUBLIC SO A TOTAL OF 10,684 ANIMALS WERE PROVIDED SHELTER SERVICES IN 2020. OF THIS TOTAL, 7,748 WERE ADOPTED, 1,223 WERE RETURNED TO THEIR OWNER, 500 WERE TRANSFERRED TO OTHER ANIMAL WELFARE ORGANIZATIONS. WE ENDED THE YEAR WITH 511 ANIMALS STILL IN OUR CARE. WE ACHIEVED AN OVERALL LIVE RELEASE RATE OF 95.7% FOR 2020.
