THE SHELTER BEGAN THE YEAR WITH 519 ANIMALS. IN 2018 A TOTAL OF 9,950 ADDITIONAL ANIMALS WERE BROUGHT TO THE SHELTER BY ANIMAL CONTROL OR THE PUBLIC SO A TOTAL OF 10,469 ANIMALS WERE PROVIDED SHELTER SERVICES IN 2018. OF THIS TOTAL, 6,825 WERE ADOPTED, 1,318 WERE RETURNED TO THEIR OWNER, 748 WERE TRANSFERRED TO OTHER ANIMAL WELFARE ORGANIZATIONS. WE ENDED THE YEAR WITH 578 ANIMALS STILL IN OUR CARE. WE ACHIEVED AN OVERALL LIVE RELEASE RATE OF 94.8% FOR 2018.
