THE SHELTER BEGAN THE YEAR WITH 578 ANIMALS. IN 2019 A TOTAL OF 10,386 ADDITIONAL ANIMALS WERE BROUGHT TO THE SHELTER BY ANIMAL CONTROL OR THE PUBLIC SO A TOTAL OF 10,964 ANIMALS WERE PROVIDED SHELTER SERVICES IN 2019. OF THIS TOTAL, 7622 WERE ADOPTED, 1,212 WERE RETURNED TO THEIR OWNER, 505 WERE TRANSFERRED TO OTHER ANIMAL WELFARE ORGANIZATIONS. WE ENDED THE YEAR WITH 716 ANIMALS STILL IN OUR CARE.
